6. SOURCE OF PERSONAL DATA

11. DATA SUBJECT'S RIGHTS

- Art. 17 - Erasure/Right to be Forgotten: Deletion of your data if it is no longer necessary for the purposes of the Controller or if you withdraw your consent;
- Art. 18 - Restriction: Restriction of processing in certain circumstances as outlined in Article 18 of the GDPR;
- Art. 20 - Data Portability: Transmission of your data to another Data Controller, where applicable under current regulations;
- Art. 21 - Objection: Objection to the processing of your data, except where the Controller demonstrates compelling legitimate grounds that override your interests, rights, and freedoms.
